Can-am / Lonestar Powersports Handicap Event #5

At the conclusion of event #5 (Saturday's handicap after the singles championship) a number will be drawn from 0-9. All contestants in event #5 who's score ends in the number drawn are eligible to shoot-off for the Can-am ATV prize. The winner of this shoot-off will win the 2021 Can-am Outlander 450 ATV prize.

No option is required to be eligible for this prize. Your entry fee and participation in this event are your ticket for chance of entry in to this shoot-off.

Shoot-off and Prize Giveaway details:

- The shoot-offs will be held with legal ATA targets after event #5 with squads shooting 2 targets per post (total of 10 targets per shoot-off round).
- The winner of this shoot-off will be the winner of the Can-am Outlander 450 ATV.
- The winner of this prize will be responsible for paying all applicable taxes, title and fees with the dealership Lonestar Powersports. Pickup and delivery options might be available depending upon proximity.
- If a minor wins this prize the contestant winner will work with Lonestar Powersports to ensure proper titling and delivery of an appropriate age range prize.
- If weather is not permitting safe completion of event #5 on Saturday, the event will be resumed at a safe time and the shoot-off for this prize will be held after event #7 on Sunday.
- If for any reason event #5 does not take place, this prize will be awarded in the same fashion in event #7 Zone 1 Handicap Championship.
- If for any reason this tournament is canceled or Event #5 and Event #7 are both canceled this prize giveaway will not be held.
- Rules governing this event will follow all normal ATA, TTA, Zone 1 and Amarillo Gun Club rules and guidelines. (including trap legal ammunition)
- If a number is drawn and no contestant shot a score ending with that number, another number will be drawn until a shooter or shooters are eligible for this shoot-off.
- Minimum of one shooter with score ending in number drawn to be eligible for prize.
- If a shooter is not able to shoot-off for any reason (equipment, health, safety etc) they forfeit the shoot-off.
- Factory (trap legal) ammunition must be used in shoot-off.
- If a shooter is Disqualified for any reason, or has shot on wrong yardage in event #5 they are not eligible to participate in this shoot-off.
- Winner may take possession of Can-am ATV once Lonestar Powersports has processed documents and taken payment for fees.

Examples of drawing and participation method:

Number drawn at end of shoot = 0 All shooters with scores ending in 0 are eligible (100/90/80/70/60...)
Number drawn at end of shoot = 4 All shooters with scores ending in 4 are eligible (94 / 84 /74/ 64/54 ..)
Number drawn at end of shoot = 1 All shooters with scores ending in 1 are eligible (91/81/71/61/51,,)
NO minimum or maximum score allowed, as long as the shooter score ends with the number drawn.
